Sub: Participation in Gujarat State Institutional Rating Framework, 2021-22.

The State Government has started a separate system of state level rating for Higher Education Institutions of Gujarat on the similar parameters of National Institutional Ranking Framework. In continuation with the same, State Government announces for the next phase of Gujarat State Institutional Rating Framework 2021-22 which is about to begin.

You are requested to participate invariably in Gujarat State Institutional Rating Framework 2021-22. KCG strongly recommends your good office to participate in Gujarat State Institutional Rating Framework-2021-22. Eligibility criteria are laid down as below

1) Eligibility Criteria for Colleges & Universities:

At least 2 batches should be graduated full time in UG or PG programs, where the duration is not less than three years for the UG programs and two years for the PG programs. Rating Process does not allow open education system.

NOTE: Interested institutions in which 2 batches have not graduated can also participate in GSIRF to understand strengths and improvements. Grade will be given in GSIRF. Such institutions are NOT eligible to participate in NIRF.

2) Letter of Intent & Fees:

For Participation, you are requested to send "letter of intent" at KCG Office along with registration fee as mentioned below. Which is approved by Department of Education.

Participating colleges will have to submit letter of intent with registration fee as mentioned below – $\,$

- A. Total Fees of Rs. 5900/- (including of GST) for Government and Grant-in-aid colleges through Cheque/D.D. in favor of "Knowledge Consortium of Gujarat" payable at Ahmedabad.
- B. Total Fees of Rs. 29,500/- (including of GST) for Private colleges through Cheque/D.D. in favor of "Knowledge Consortium of Gujarat" payable at Ahmedabad.

There is no specific format for Intent letter. But, letter of intent shall include information regarding details of GSIRF Nodal Officer, details of Cheque/DD of registration Fee. Also, send a copy of your College's "GSTIN Normal Registration Certificate" and not a GST TDS Registration Certificate.

The details need to be uploaded in the Google form link which will be shared shortly. For each category, Institute needs to apply separately.

For participation in GSIRF 2021-22, you are requested to deposit application fees with GST as mentioned in above table, through Cheque/DD in favor of "Knowledge Consortium of Gujarat" payable at KCG Office, Ahmedabad.

The last date for sending your letter of intent is Date: 12/05/2022 & Time: 05:00 PM. Please communicate and also send the contact details of GSIRF Nodal Officer of the College, so that necessary coordination can take place.

3) Format for letter of Intent:

There is no specific format for Intent letter. But, letter of intent shall include information regarding details of GSIRF Nodal Officer, details of Cheque/DD of registration Fee. Also, send a copy of your College's "GSTIN Normal Registration Certificate" and not a GST TDS Registration Certificate.

4) Bank details for payment processing:

For Participation in GSIRF 2020-21, A Participating College is required to deposit necessary registration fees of Rs.5,000/- \pm 18 % GST per college which has been approved by Department of Education.

For payment towards GSIRF Application, you are requested to deposit an amount of application fee with 18% GST through Cheque/DD in favor of "Knowledge Consortium of Gujarat" Payable at KCG Office, Ahmedabad by Courier or Speed Post.

The last date for participation in GSIRF 2020-21 is 28-12-2020, 6.00 pm. Please send the contact details of GSIRF Nodal Officer of the College, so that necessary coordination can be made available.

After receipt of the letter of intent & application fee, KCG Office will send "Data Collation Sheet" for the Process of Rating. The said data collation sheet has to be filled by all participating colleges within prescribed time limit. If required, Webinar/Workshop for providing guidance & solving query will be held.
