

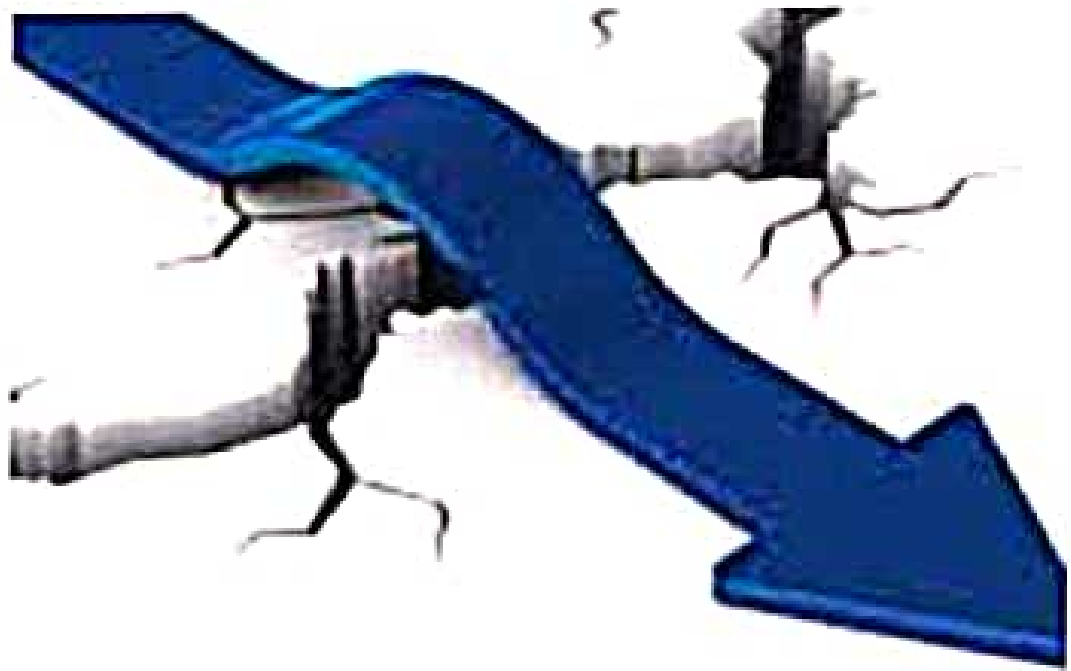
Abstract :

Digital banking refers to the act of performing banking and financial transaction without the use of physical cash, coins or bills. The ultimate objective of the study was to study current scenario and challenges of digital banking in India. Secondary data spanning from 2014 to 2019 were collected from the RBI reports. It was found that the mobile connection are growing at a rapid pace. For every 100 Indians there were 87.28 cellular phones in the year 2017. 293 million Basic Savings Bank Deposit (BSBD) Accounts opened since 2014 is a testimony of the penetration of financial inclusion. There is poor connectivity in rural areas. In addition to this, a lower literacy level in poor and rural parts of the country, make it problematic to push the use of plastic money on a wider scale. This is being overcome by application BHIM (Bharat Interface for Money) launched by the Prime Minister which will work on USSD i.e without mobile internet. It was also found that Value of usage of Mobile Banking was Rs.103530 crore in 2014-15, after five year in 2018-19 this value become Rs. 2958407 crore. The usage of Mobile Banking value was increased by 2858% in the five years period. We can see that after demonetization in 2016, the usage of Mobile Banking increase rapidly in India. The implication of this study is that policymakers in future will have a fair idea when framing policies about Fintech in the future.

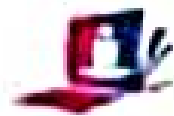

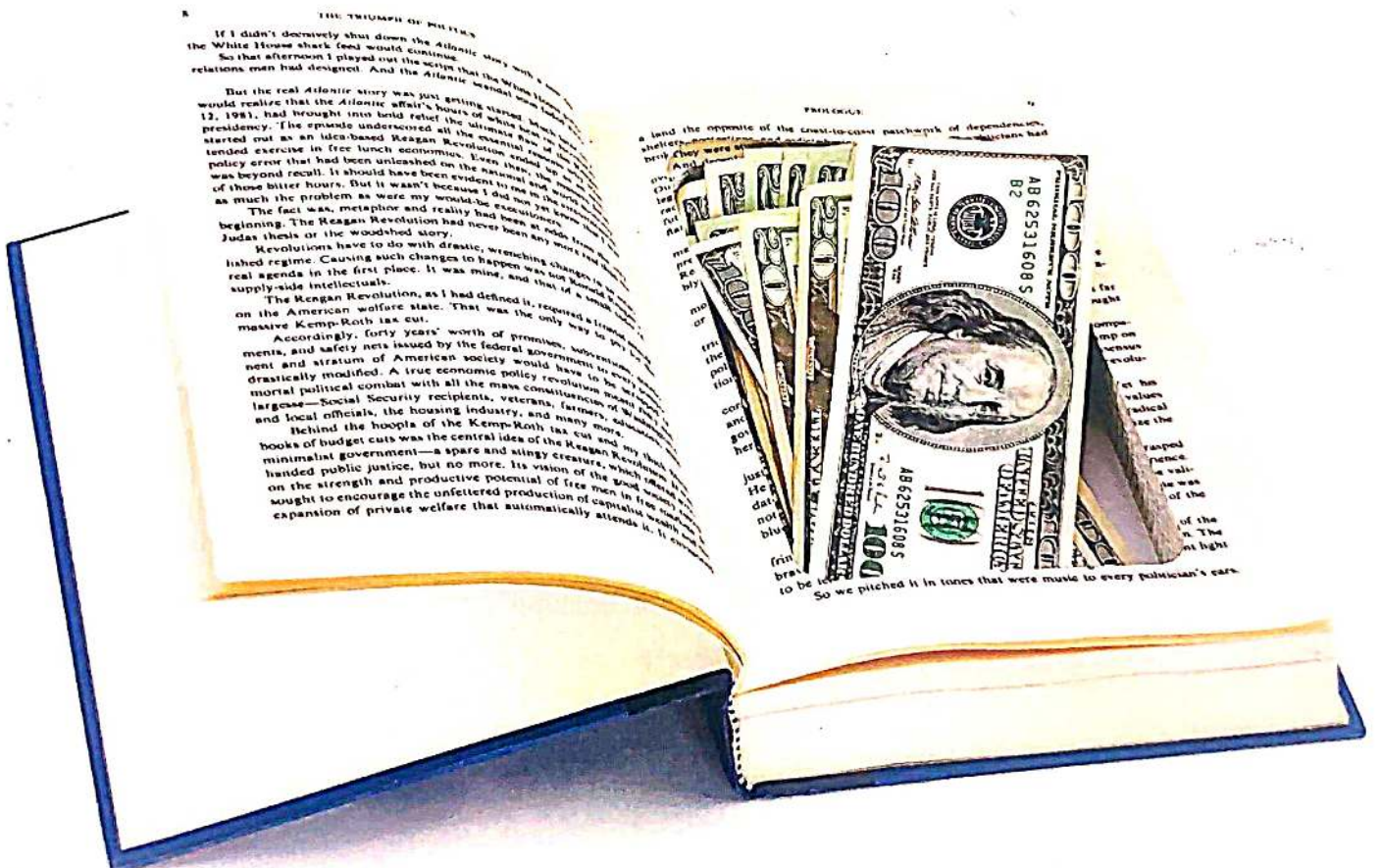

SOCIAL ACCOUNTING

Social accounting (also known as social accounting and auditing, social accountability, social and environmental accounting, corporate social reporting, corporate social responsibility reporting, non-financial reporting or accountability) is the process of communicating the social and environmental effects of organizations' economic transactions to particular interest groups within society and to society at large. Social accounting is commonly used in the context of business, or corporate social responsibility, although any organisation, including NGOs, charities, and government agencies may engage in social accounting. Social Accounting can also be used in conjunction with Community-Based Monitoring.

Social accounting is often used as an umbrella term to describe a broad field of research and practice. The use of more narrow terms to express a specific interest is thus not uncommon. Environmental accounting may e.g. specifically refer to the research or practice of accounting for an organisation's impact on the natural environment. Sustainability accounting is often used to express the measuring and the quantitative analysis of social and economic sustainability. National accounting is a narrower usage in concentrating on the nation as the aggregable unit of analysis and economics as a method of analysis.

In an increasingly complex world with increasingly powerful organisations it seems inevitable that society – or groups in society – would become anxious about whether these organisations could be encouraged to match that power with an appropriate responsibility.

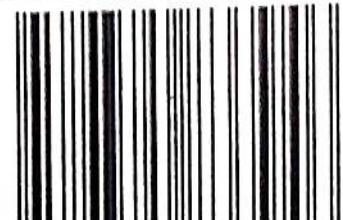
