MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is entered into on the 27th day of November, 2019 by and between **Tata Consultancy Services Ltd.**, a company incorporated under the Companies Act, 1956 and having its corporate office at TCS House, Raveline Street, Fort, Mumbai 400001, India (hereinafter referred to as "TCS"), and Tolani Commerce College, Adipur, an education institute and having its principal office at Adipur (hereinafter referred to as "Institute").

TCS and Institute are both hereinafter referred to as "Party" individually or "Parties" collectively as the context may require.

WHEREAS Institute is engaged in providing educational degrees at graduate and postgraduate level in various streams and is affiliated to KSKV Kachchh University, Bhuj
WHEREAS TCS is inter alia engaged in the business of provision of various information technology services, business solutions, consultancy and outsourcing services worldwide; and

WHEREAS, the Parties recognize each other competencies and hereto agree that a strategic relationship between them will benefit each other.

NOW THIS MOU aims to capture the understanding reached between TCS and Institute regarding each other's roles and responsibilities;

I) UNDERSTANDING

This MOU is intended to cover a specific collaborative effort between TCS & Institute under the academic interface program driven by TCS under which TCS will work towards developing and designing and/or providing industry specific application oriented courses ("TCS Designed Course(s)") which can be offered by the Institute as elective courses for specific degree specializations ("Option 1"); and/or as full curriculum specializations streams in Business Process Services / Management and related domains ("Curriculum") at the bachelor's degree level ("Option 2") or post-graduate degree level ("Option 3"), as may be agreed to by the Parties and details outlined in **Annexure A**. The term 'Curriculum' as used in the MOU shall apply only when Option 2 and/or Option 3 are agreed to in Annexure A.

The agreement between TCS and Institute would be effective from 27th November 2019 and shall be valid up to 30th April 2021

-II) ROLES AND RESPONSIBILITIES:

A. Role of TCS:

- TCS agrees to design and develop TCS Designed Course(s) identified in the Annexure A. The final choice of TCS Designed Course(s) to be offered by the Institute to its students will be jointly agreed between TCS and the Institute.
- TCS role will be restricted only to designing and developing the course contents and curriculum of the TCS Designed Course(s) and/or assisting in designing the Curriculum (if agreed and outlined in Annexure A). After review and sign off by the Institute, the TCS Designed Course(s) / Curriculum (where agreed to in Annexure A) will be taught and administered by faculty from the Institute. TCS will not be involved in the administration and the evaluation of the TCS Designed Course(s) / Curriculum. The administration and

evaluation of the TCS Designed Course(s) and other core topics included in the Curriculum (where agreed to be offered in Annexure A) along with conferring of the degree to successful students enrolled in the Curriculum will be done by the Institute. On case to case basis, TCS may also consider the deployment of its experts as trainers for delivering a part of the offered TCS Designed Course(s) / Curriculum.

- TCS will consider incorporating the suggestions from the Institute about having as much practical understanding during the design of the course contents and curriculum of the TCS Designed Course(s) by incorporating appropriate case studies, simulations, exercises that can help students visualize and understand the application of concepts in real time business solutions.
- TCS may provide only suggestion for the evaluation of student performance through various forms of assessments. However the final decision on the process of evaluation as well as the actual assessment would be at the sole discretion of Institute and will not be part of TCS responsibility.
- TCS will conduct a Train the Trainer Program ("TTT Program") for appropriateduration where specialists from TCS will transition the knowledge and approach to teach the TCS Designed Course(s) to the nominated faculty of Institute. On successful completion of this Program, all the faculty members will be deemed as TCS certified faculty for delivery of the course. The TTT Program may be scheduled and repeated as per requirement with mutual agreement between TCS and Institute.
- The entire effort from TCS end is voluntary and objective is to work along our stakeholder community (in this case educational institutions / Universities) to build capability and benefit for the students as well as faculty by way of offering courses in areas of knowledge closer to industry practice.
- There would be no linkage with campus placements as part of this program as these are two distinct activities. The placement activities are separate and the participation of Institute for the TCS Designed Course(s) has no bearing on placement activities that TCS conducts at colleges and universities each year.
- TCS at this point will be providing this course design, content and training sessions as a voluntary effort keeping in mind the Tata Group Philosophy of working towards benefiting the societies and stakeholders with whom we work.
- Outstanding students' contributions in all possibility will be show-cased by TCS at industry level forums along with due acknowledgement to the students concerned.
- At the end of the course, TCS may at its option, reward / recognize individual students for exemplary achievements based on participation, discussion, contribution, assignment submission etc. during the course work.

B. Role of Institute:

- Institute shall ensure that it holds all valid permissions, authorizations, approvals and consents, licenses and registrations, which may be required under the applicable laws, policies and procedures prevalent from time to time, for launch, administration and instruction of the TCS Designed Course(s) and Curriculum (if agreed to in Annexure A) and the same shall be kept valid and subsisting throughout the period of this MDU or till the completion of the TCS Designed Course(s) / Curriculum, whichever is later.
- Institute will undertake the role of selecting the core topics (that will fit into the Curriculum) and faculty members who will undertake the ownership for teaching those selected topics.
- Institute will ensure to provide equal status to the TCS Designed Course(s) / Curriculum (at par with all other courses) while offering it to students applying to the Institute. This will be done by placing the option of this course curriculum in all communication medium (College Website, Student Application forms, Brochures etc.) to ensure maximum students undertake the TCS Designed Course(s) / Curriculum.
- Institute will set highest standards of selection for the students and ensure that the students who undertake the TCS Designed Course(s) / Curriculum would put in full effort and contribution to make learning outcomes successful. Focus would be on ensuring students who have a great propensity to participate actively and contribute to learning in a group as well as individual mode.
- Institute shall nominate a designated faculty member who will be the single point of contact for managing the administration and completion of the TCS Designed Course(s) / Curriculum. The faculty will be responsible from Institute side to help TCS team in all administrative and management activities that will be helpful in smooth launch and completion of the course.

- Institute should ensure timely nomination of faculty for attending the TTT Program and delivering the TCS Designed Course(s) in a timely and satisfactory manner and is based on the broad guideline as below. Final choice on the selection of faculty will lie with Institute.
 - a) Post-graduation with solid academic achievements relevant to the TCS Designed Course(s).
 - b) 5+ years' experience in teaching the specific courses which they would be teaching (flexibility allowed)
 - c) Familiar with recent developments in related field
 - d) Effective communication and articulation of scenarios
 - e) Ability to drive interactive sessions
 - f) Willingness to learn and lead
- Institute will own the responsibility of conducting the exams/assessments of student performance for the TCS Designed Course(s) and across all the subjects of the Curriculum. As an input it may consider the assessment criteria as suggested by TCS for assessment to be done through written exams, internal assessments, market visits and take home assignments by the nominated faculty, where each parameter may have an assigned weightage so that students are assessed effectively for their all-round performance.
- Institute shall ensure that all the students selected for the TCS Designed Course(s) / Curriculum will sign individual confidentiality undertaking substantially in the format as set forth in Annexure – B hereunder, to ensure that the course material is not used or disposed off inappropriately and take utmost care not to copy or share the course hand outs and materials that are TCS provided copyrighted material with anyone else. The course material is solely for the students' learning purposes and only students, who undertake the TCS Designed Course(s) / Curriculum shall possess the course material at any time. The course material has to be destroyed / disposed only by shredding, in order to avoid any unauthorized use.
- Institute shall ensure that the faculty from Institute who would be trained through the TTT Program will sign individual confidentiality undertaking, substantially in the format as set forth in Annexure – C hereunder, to ensure that the course material is used appropriately only for the purpose of instruction of the TCS Designed Course(s) / Curriculum. The faculty should not use this course material for other courses or for any other purpose whatsoever and also should not dispose it in a manner that can lead the course material falling in hands of those who should not be recipients of the course work.
- The faculty trained by TCS would teach the TCS Designed Course(s), only as long as this MOU is valid. Once the validity of this MOU is over, they would need to be recertified with a TTT Program post renewal of the MOU.
- Institute shall ensure availability of all requisite facilities, infrastructure, cooperation, etc. required to seamlessly deliver the TCS Designed Course(s) / Curriculum to the applicable students. The lectures are to be scheduled during the normal working days of the Institute or as decided by Institute. In cases where TCS' assistance is availed by Institute for delivery of the TCS Designed Course(s), TCS and Institute will mutually agree to a schedule for the same. Institute recognizes that timely and continued provision of the facilities by Institute is a condition precedent to the completion of the TCS Designed Course(s) / Curriculum in time. Any delay or failure in the provision of agreed facilities will hamper the timely completion of the course, and TCS shall not be held liable for the same.
- Institute shall permit the applicable TCS faculty/personnel engaged pursuant to this MOU, reasonable access to the premises of Institute, for the purpose of delivery of the TTT Program or to fulfill its role under this MOU or assist the Institute in any other manner in relation to this MOU.
- At the end of the TCS Designed Course(s) / Curriculum, any formalities with respect to awarding certificate of course completion to the students will be done by Institute in accordance with the rules/ procedures followed by Institute.
- At the end of the course Institute shall allow TCS to make pre-placement offers to the students who are part of the course based on a selection criteria defined by TCS. Institute shall also provide first slot to TCS during campus recruitment/ placement and Institute will facilitate the process for students to accept an offer from TCS.

III) OTHER TERMS & CONDITIONS

- TCS and the Institute will jointly evaluate and agree on applicable fees or service charges (if any), to cover the costs of designing, developing, training, branding, delivering and sustaining the TCS Designed Course(s) / Curriculum that may be offered in collaboration with TCS and any costs associated therewith such as travelling, accommodation, etc.

Upon mutual agreement, TCS and Institute may at any time enter into a specific definitive agreement(s) (hereinafter referred as "Definitive Agreement(s)") setting out therein the TCS Confidential

mutually agreed detailed terms and conditions applicable to the various courses to be provided by TCS under such Definitive Agreement(s).

- c. For the TCS Designed Course(s) which are agreed to be implemented, TCS will provide one master copy of course material in hard copy form to the Institute, which will be received by the faculty duly designated by Institute in writing to TCS. The said course material may be reproduced in hard copy form only, solely for the purpose of being issued by the duly designated faculty to the students who enroll for the TCS Designed Course(s) / Curriculum for the duration of the course. Except as permitted herein, the course material provided by TCS shall not be reproduced, copied, translated, adapted, broadcasted, hosted or transmitted (including electronically) in any form. The supporting material, if any, for faculty members will be separately provided to the faculty members and shall be used by the faculty members only for the purposes of the instruction of the TCS Designed Course(s) at the Institute. Institute shall ensure that the original master copy of course material and supporting material for faculty members provided by TCS and copies of the same including portions thereof (i) is treated strictly as confidential documents; (ii) shall only be in the possession of the designated faculty of Institute; and (iii) shall not be displayed or circulated in libraries or forums where any person not enrolled under the TCS Designed Course(s) / Curriculum may access the same.
- For the entire process involved for offering the TCS Designed Course(s) / Curriculum, Institute will seek prior written permission from TCS before publishing any related information regarding this TCS Designed Course(s) / Curriculum offering initiative in collaboration with TCS, in the press, media, social network, blogs, internet and in any other allied public channels.
- Unless otherwise agreed by the Parties separately in writing, each Party will be responsible for its own individual costs in conducting its duties and obligations under this MOU.

IV) INTELLECTUAL PROPERTY RIGHTS

- Institute agrees and acknowledges that any and all intellectual property rights in or to course contents and curriculum of the TCS Designed Course(s) and TTT Program and any and all modifications, enhancements, alterations, additions, adaptations, translations to the same, or derivative works thereof, or feedback received with respect to them, shall be done only by or with prior written permission of TCS and vest with TCS and/or its licensors. For the term of this MOU, TCS grants to the Institute a non-exclusive, non-transferable, non-sub-licensable, limited right and license to use and reproduce the course material in hard copy form only for the purposes of, and as permitted under, this MOU. All rights not expressly granted herein shall remain with TCS.
- Institute agrees to retain all of TCS' and/or its licensors' logo, trademark, copyright notices and other proprietary markings or notice on the course material. Institute shall not permit any persons to, remove, alter, obscure or otherwise render illegible any of TCS' logo, trademark, copyright notice or other proprietary or confidentiality markings that may be placed on the course material or part thereof provided to Institute hereunder without prior written approval of TCS. Institute shall include on all copies of all or part of the course material a reproduction of TCS' and/or its licensors' logo, trademark, copyright notices and other proprietary markings or notices as included in the course material provided by TCS.
- TCS shall also continue to own all and any Intellectual property developed prior to, or independently of this MOU.
- By entering into this MOU, Institute covenants and undertakes:
 - (a) To respect TCS' intellectual property,
 - (b) Not to use TCS' intellectual property without the prior express written consent of TCS;
 - (c) Ensure the confidentiality of such intellectual property of TCS within enrolled students and nominated faculty;
 - (d) Not to use or permit use TCS' intellectual property other than for the purpose and duration of this MOU.
 - (e) Promptly report any misuse of the TCS' intellectual property which comes to its notice and assist and support TCS in remedying and/or protecting any misuse/encroachment of TCS' intellectual property subject of this MOU.
- Institute agrees that it shall not gain by virtue of this MOU any rights of ownership or any other interest, right, or title in or to any copyrights, patents, trade secrets, trade marks, or any other intellectual property or proprietary rights owned by TCS. Except as otherwise explicitly agreed between the Parties, any and all works developed in the course of performing obligations pursuant to this MOU, including all intellectual property rights in or related thereto, and all new inventions, innovations, works or ideas developed by TCS in the course of performance of its activities under this MOU will belong to TCS.

- If the Parties undertake any joint development in the course of providing services under this MOU, any such joint development will be governed by a separate agreement to be negotiated in good faith by the Parties prior to the commencement of any joint development efforts.
- Neither Party shall use any name, trademark, service mark or symbol of the other Party in any publicity release or advertising material or for any other purpose whatsoever without securing the prior written consent of that other Party. The Parties may, however, mention the non-stylized name of the other Party and areas of collaboration in their official websites, presentations and analyst reports and include the existence of this Memorandum in its regular list of academic/industry collaborations. Institute agrees that any and all use of TCS name and trademarks shall be in accordance with the provisions of Annexure – D.

V) CONFIDENTIALITY


- During the term of this MOU, TCS may disclose to Institute its Confidential Information. Confidential Information shall mean all information marked "Confidential" or under any similar legend indicating the confidentiality of the information or information which by its nature is confidential or acknowledged and agreed herein as confidential, except such information as is (a) previously known to Institute at the time of disclosure and not subject to confidentiality under any other agreement between the Parties, or (b) independently developed by Institute and not derived from the Confidential Information supplied by TCS or the participation of individuals who have had access to Confidential Information of TCS, (c) disclosed to Institute by a third party who lawfully acquired such information without restriction, and is not subject to confidentiality obligations, or (d) in or subsequently comes into the public domain (other than as a result of a breach of this MOU), or (e) required to be disclosed by Institute by law, regulation, court order or other legal process. Institute acknowledges and agrees that course contents and curriculum of the TCS Designed Course(s) and TTT Program is Confidential Information of TCS irrespective of whether it is labelled as confidential or not.
- Institute shall hold such Confidential Information in strict confidence for TCS and shall not use it for any purpose except in furtherance of the relationship set forth in this MOU, or except as it may be authorized by TCS in writing. Institute shall further be responsible for the compliance of the foregoing by its students, employees, faculty or agents who have access to Confidential Information in relation to the purpose of this MOU.
- Institute acknowledges and agrees that a breach of any of its obligations contained herein will result in irreparable injury to TCS for which there will be no adequate remedy at law, and TCS shall be entitled to apply for equitable relief, including injunction and specific performance, in the event of any breach or threatened breach or intended breach of its obligations herein by the Institute. Such remedies, however, shall not be deemed to be the exclusive remedies for any breach of the obligations but shall be in addition to all other remedies available at law or in equity.
- All Confidential Information is provided as is, without any warranties express, implied or otherwise, regarding its accuracy, completeness or performance.

VI) TERMINATION

- Either Party may terminate this MOU by giving ninety (90) days advance written notice to the other Party. On termination, each Party shall return to the other party all such confidential and proprietary information, documents and reference material, and any copies thereof of the other Party in its possession. If the MOU expires or notice of termination is issued during the Academic Year when the TCS Designed Course(s) / Curriculum is/are in progress, the termination shall take effect post completion of the batch(es) that has/have already opted for the TCS Designed Course(s) / Curriculum. New students/batches will not be offered the TCS Designed Course(s) / Curriculum once the termination notice has been issued. The right of each Party to terminate this MOU with immediate effect for material breach of the terms of this MOU (that remains uncured after thirty (30) days of written notice thereof or that are not susceptible to cure) remains unaffected.
- All such obligations and terms of this MOU that are required to survive the expiration or termination of this MOU, including but not limited to, intellectual property rights, confidentiality, limitation of liability, shall survive such termination.
- This MOU can be extended or terminated by mutual consent of the Parties in writing. Notice period not to renew.

VII) PERIODIC REVIEW

- The Parties agree that the persons nominated herein below as the point of contact for each Party (or their respective nominees) shall meet at a frequency mutually decided by TCS and Institute, either personally or through a teleconference to review the progress and plan the future course of action, to accomplish the objectives of this MOU as per the mutually agreed schedule.

- Institute will be completely responsible for ensuring compliance towards all statutory provisions applicable to and governing the employment of its employees and representatives, deployed and would ensure compliance to provisions of statutes, as amended and applicable from time to time for such employees and representatives. Under no circumstances shall employees, agents and representatives of Institute, represent as or be construed as employees/agents of TCS.

IX) LIMITATION OF LIABILITY

- Institute agrees that any information or material provided / disclosed by TCS is on "as is" basis without any warranty or representation of any nature whatsoever, as to any matter, including but not limited to, warranty of fitness for a particular purpose or merchantability. TCS shall not be liable for any direct, indirect, incidental, special or consequential damages, or damages for loss of profits, revenue, data or use, incurred by Institute or any third party arising out of or in connection with this MOU or the subject matter of this MOU, whether in an action in contract or tort or any other legal theory.

X) GOVERNING LAW/ARBITRATION/VENUE

MEMORANDUM OF UNDERSTANDING BETWEEN TOLANI COMMERCE COLLEGE - ADIPUR AND SATYAM ENTERPRISE - GANDHIDHAM FOR SERVICE OF R.O.

A) The Parties:

Tolani Commerce College - Adipur (hereinafter Tolani Commerce College (TCC) and Satyam Enterprise Gandhidham, wish to conclude this memorandum of understanding (hereinafter :MOU) for service of 25LPH R.O. 5 year (2019-20 to 2023-24) AMC in Tolani Commerce College:

Satyam Enterprise Specialist in domestic & industrial R.O. system services, provide service of R.O. maintenance and services quarterly visit in Tolani Commerce College.

1. Terms & Conditions for Annual Maintenance Contract for the Repairing & Servicing work of RO Machines.

SCOPE OF WORK-

- i. Attend break down calls and repair of unit.
- ii. Preventive service maintenance every three months, during which the bidder shall replace all filters and membrane of the machine.
- iii. All spares of RO machines like Booster Pump, SMPC, Solenoid Valve, Flood Valve, UV Lamp, UP Choke, Membrane, Filter, Spun, Sediment, Sensor, UV lamps, Drips, Body and Carbon filters, internal electrical interconnections, and internal water interconnections. Autocut off functions with all RO machines connected to water coolers and/or water tanks.
- iv. Bidder to quote the prices of the body of the RO machines of various capacity. The prices shall be valid for the period of one year. The bidder may be asked to replace any of such part, if the institute found it necessary to replace the same for proper functioning of machine.





- i. This being a comprehensive annual maintenance contract, for the period from 2019-20 to 2023-24, the bidder is requested to inspect all the "RO water purifying Machines" and become well acquainted very carefully about the nature of work required to be carried out and then quote rates accordingly to make the "RO Water purifying Machines" in perfect working order & to maintain the same in working order till 21.09.2024. At the end of the contract period, the bidder shall hand over the "RO Machines", in perfectly working order to the new agency. In case, any of the "RO Machine or part of it" is found not in perfectly working condition at the time of handing over, the cost incurred by the institute in getting the "RO Machine or part of it" repaired from other agency, shall be deducted from the amount payable to the tender.
- ii. The Bidder shall use only new and original genuine spares including all other consumable parts etc. and be shown to the Project Manager of authorized person before its use, which are needed for the repair of the unit. Nothing shall be supplied by the institute. Old replaced parts / material will be the property of the bidder and the rates are to be quoted by the bidder accordingly. Record for the purchase and utilizing the materials along with the purchase bills shall be maintained by the agency and the same shall be shown to the Project Manager as and when demanded by him.
- iii. If, the work is not found satisfactorily, the work can be got done from another agency at the risk & cost of the bidder. A service log book has to be maintained by the bidder, in which all the repair and maintenance work shall be indicated and duly signed by the project manager or any other person assigned by the project manager.
- iv. Institute will provide nothing to the bidder, except free electricity & water at fixed points, for the completion of the assigned repair works. The rates are to be given accordingly.
- v. The repair works as far as possible be done at the Institute during Institute working hours.
- vi. The Institute will pay no separate charges for cartage for taking the machines or parts to the bidder repair site, if so required for any repair. The rate is to be quoted inclusive of all such charges, if applicable, for any type of such repair.
- vii. 

A) The Parties:

Arihant Sales & Services Gandhidham (ASS) specialist in drinking water system and tank cleaning, provide service of tank cleaning quarterly in Tolani Commerce College.

Period of MoU: 2022-2025 (3Years) for 12 tank cleaning quarterly.

SPECIAL TERMS AND CONDITION:-

A) WORK SPECIFICATION : CLEANING OF WATER TANKS/TANK BY MECHANIZED SYSTEM

STAGE-I: MECHANIZED DEWATERING:- Photograph of each and every 12 WATER TANKS QUARTERLY (with sludge and without sludge) before and after cleaning should be forwarded to Principal of Tolani Commerce College Adipur on official e-mail within ten days after cleaning

Mechanized dewatering should be done by submersible dewatering pump having, suitable outlet and discharge and control panel.
The details of Motor cable seal material of construction and control panel should be furnished.

STAGE II: DESILTING AND REMOVAL OF LEFT OVER DIRTY WATER SLUDE WITH A SLUDGE REMOVAL PUMP:- Proper sludge pump and wash out pipes should be used.







(2) BINDING

(3) CHANGES TO MEMORANDUM

If and to the extent that a party performance of any its obligations under this MOU, hindered or delayed by fire, flood, earthquake, elements of nature or acts of God, pandemic, acts of war, terrorism, riots, civil disorders, rebellions or revolutions or any other similar cause beyond the reasonable control of such party (each, a "force majeure event") and such non-performing, hindered or delay could not have been prevented by reasonable precautions, then the non-performing, hindered or delay will be excused for such non-performance, hindrance or delay, as applicable of those obligations effected by the force majeure event for as long as such force majeure event continues and such party continues to use its best efforts to recommence performance whenever and to whatever extent possible without delay., including through the use of alternate sources, workaround plans or the means. 



**AGREEMENT FOR ICSI KUTCH STUDY CENTRE
BETWEEN
THE INSTITUTE OF COMPANY SECRETARIES OF INDIA, NEW DELHI
AND
TOLANI COMMERCE COLLEGE – ADIPUR – KUTCH**

Whereas the Institute of Company Secretaries of India, constituted under the Company Secretaries Act, 1980 to develop and regulate the profession of Company Secretaries in India being solely authorised to conduct coaching and examinations for the award of Professional qualification / Membership of the Institute and whereas "ICSI Kutch Study Centre" would create synergy between the university education and professional education to enhance the quality of education imparted to the ICSI students, the study centre proposed to be operated and managed by Tolani Commerce College of Adipur, Kutch will be set up on self-sustainable basis.

1. Study centre shall function from the premises of recognised university/ college having proper recommendations of the concerned Regional Council/Chapter.
2. Study centre shall be run by faculty or Department of Commerce or any other department having relevance to CS Course, by whatever nomenclature, on self-sustainable basis as per these guidelines.
3. The respective department of the university/ college shall operate and manage the ICSI study centre. Study centre shall in no case be termed as an agent or a partner or a representative of ICSI except for the limited purpose of providing class room teaching to CS students and other responsibilities covered in the agreement between the two Institutions.
4. Head of respective department of university / college in which the study centre has been set up or his representative will be designated as Director of the CS Study Centre.
5. Study Centre shall not engage itself any activity or deal with a matter which are prejudicial to the interests and image of the Institute
6. These study centres shall be entitled to use the words and description "ICSI (name of city)Study Centre"
7. The study centres would have full autonomy in deciding the fee to be charged from the students for the Class Room Teaching activity but the Institute would not provide any financial support/compensation to the study centres on any account.
8. ICSI Head Office/Regional Council/Chapter shall have no share in the revenue generated by respective study centres.

9. The Study Centre shall impart education with best faculty for various stages of ICSI Course Curriculum on the lines prescribed by ICSI.
10. The Study Centre shall conduct Career Counselling, suitably advertise and attract students for enrolment to CS Course and disseminate information regarding Company Secretaryship course
11. Facilitating registrations to the CS Course through on-line mode. The Fee will be accepted by the Institute through online mode and the University/ College shall provide reasonable infrastructure (computer with internet connectivity, scanner, etc.) to enable the students to register online for CS Course. Students who are not having Credit/ Debit Cards may remit the fee through Bank Challan in which case cash can be deposited with designated banks (at present Canara Bank).
12. Provide at least one room space for ICSI representative office at University/ college campus.
13. Students of study centre shall be allowed access to the library of concerned department in which the study centre has been setup.
14. Members of Central Council, Regional Councils of ICSI or Members of the Chapter Managing Committees are not eligible to act as Faculty in the classes conducted by Study Centres.
15. The study centre shall submit quarterly MIS covering the activities conducted during such period like Details of Career Awareness Programmes/ Counselling Sessions conducted, Details of Registrations Facilitated(*) with registration number, Details of Classes Conducted with registration number of the students etc. to the Regional Council/Chapter to which it is attached with a copy to the ICSI HQ. (*) as per format decided by the Institute from time to time.
16. The college shall maintain a permanent display board 'CS Kutch Study Centre' on the boundary wall of the college and also within the premises where the study centre is located.
17. The designated room shall be properly maintained with daily cleaning, proper lighting and whitewash.
18. ICSI shall share and suggest ways and means for effective conduct of classes by the centre
19. ICSI shall Suggest / Depute faculty on specialised subjects as and when requested by the study centre

20. ICSI shall Assist in popularising the Class Room Teaching conducted by various study centres - Study centre can advertise/publicise conduct of classes in the Institute's student e-bulletins 'Student Company Secretary' and 'CS Foundation Course' bulletin free of cost.
21. ICSI shall pay Honorarium as per the prevailing 'ICSI Guidelines of Counsellors' of that day, for successful registration of students on receipt of quarterly MIS.
22. Apart from specific guidelines given above, general guidelines relating to conduct of class room teaching issued by the Institute are also applicable to the study centres as far as engagement of faculty, feedback, etc.
23. Faculty engaged for the purpose, as far as possible shall be in accordance with the guidelines and student teacher ratio should be 40:1 that is a maximum of 40 students per teacher.
24. The honorarium payable to the faculty members shall be decided by the study centres.
25. To the extent possible the faculty of the University/college shall be engaged to take the classes, subject to fulfilment of criteria.
26. Propagation of the schedule of classes through bulk SMS/ E-Mail among the concerned students will be through the Institute only and the same will be chargeable as per rates fixed by the Institute from time to time.
27. The Study Centre shall indemnify the Institute that the interests of the students will be protected at all times.
28. There would be at least one room for the representative office.
29. ICSI shall not pay any rent for the space provided by the University for the Representative Office.
30. The Director of study centre may engage any person at the representative office to register the students and render other administrative activities. Such person shall not in any way be treated as an agent or a partner or a representative or employee of the ICSI. No reimbursement of any type shall be made by ICSI for this arrangement.
31. The director of study centre shall engage and pay to the person engaged to register the students and undertake administrative functions of the study centre. No reimbursement of any type shall be made by ICSI for this arrangement.
32. The person to be appointed for manning the centre office to be from the institution, in order to have effective coordination with the college administration and to ensure access

to the infrastructure facilities of the Institution as prescribed under these guidelines, to run the centre effectively.

33. Such study centre would be monitored and coordinated by Directorate of Student Services at Headquarters through the respective Regional Council / Chapter. ICSI shall keep a possible ordinary control to ensure quality of education through supervision by deputing its own personnel in the classes or having confidential or independent feedback from the students.
34. There would be a coordination committee having representative from the university/ college and ICSI for monitoring the performance of the study centre at regular intervals, preferably every quarter.
35. ICSI shall not incur or suffer any kind of liability – legal, financial or otherwise – with regard to any obligations incurred by the study centre.
36. The Regional Director of respective Regional Council shall enter into an agreement between the respective University / college for setting up of Study Centre in its respective jurisdiction.
37. The agreement (Renewal) would be valid for a period of ONE year and can be extended further on year to year basis, as mutually agreed between the respective university/ college.
38. Unless the validity of the recognition renewed/extended, after due period, the study centre would not carry its activities. In case, a particular study centre is derecognised or validity withdrawn, it would stop the activities immediately.
39. It is the responsibility of the Centre to deduct TDS as applicable in respect of payment made by it for running the centre. It shall also fulfil all the compliances arising out of TDS deductions like remittance and filing of returns from time to time as prescribed under the law.
40. Likewise, the study centre would ensure to comply GST provisions arising out of payment to the faculty handling the classes and for such other services as applicable.
41. Study centre to maintain its accounts as per the standard and established practices and norms and get them audited at the close of financial year and send the audited accounts to the RC/Institute periodically for their information.






Whereas the Institute of Company Secretaries of India, constituted under the Company Secretaries Act, 1980 to develop and regulate the profession of Company Secretaries in India being solely authorised to conduct coaching and examinations for the award of Professional qualification / Membership of the Institute and whereas "ICSI Kutch Study Centre" would create synergy between the university education and professional education to enhance the quality of education imparted to the ICSI students, the study centre proposed to be operated and managed by Tolani Commerce College of Adipur, Kutch will be set up on self-sustainable basis.

1. Study centre shall function from the premises of recognised university/ college having proper recommendations of the concerned Regional Council/Chapter.

3. The respective department of the university/ college shall operate and manage the ICSI study centre. Study centre shall in no case be termed as an agent or a partner or a representative of ICSI except for the limited purpose of providing class room teaching to CS students and other responsibilities covered in the agreement between the two Institutions.
4. Head of respective department of university / college in which the study centre has been set up or his representative will be designated as Director of the CS Study Centre.
5. Study Centre shall not engage itself any activity or deal with a matter which are prejudicial to the interests and image of the Institute
6. These study centres shall be entitled to use the words and description "ICSI (name of city)Study Centre"
7. The study centres would have full autonomy in deciding the fee to be charged from the students for the Class Room Teaching activity but the Institute would not provide any financial support/compensation to the study centres on any account.

11. Facilitating registrations to the CS Course through on-line mode. 27. The Study Centre shall indemnify the Institute that the interests of the students will be protected at all times.
28. There would be at least one room for the representative office.
29. ICSI shall not pay any rent for the space provided by the University for the Representative Office.
30. The Director of study centre may engage any person at the representative office to register the students and render other administrative activities. Such person shall not in any way be treated as an agent or a partner or a representative or employee of the ICSI. No reimbursement of any type shall be made by ICSI for this arrangement.
31. The director of study centre shall engage and pay to the person engaged to register the students and undertake administrative functions of the study centre. No reimbursement of any type shall be made by ICSI for this arrangement.
32. The person to be appointed for manning the centre office to be from the institution, in order to have effective coordination with the college administration and to ensure access







WHEREAS: Tolani Commerce College-Adipur needs Healthcare related services for students and its staff including all stakeholders.

WHEREAS: Dr. Naresh L. Joshi is desirous to join the said and is willing to extend medical facilities and treatment to members covered under such scheme the agreed terms and conditions, and the service provider is interested in providing the beneficiaries and students of Tolani Commerce College all primary medical facilities services all as detailed in this agreement herein below; and

WHEREAS: The parties are interested in putting their agreement in writing, all in accordance and subject to that agreed and detailed in this agreement.

Therefore, it is agreed and conditioned between the parties as follows:

Article 1: Effective Date

- 1.1 The Parties hereby agree that the Effective date of the Agreement shall be the date on which the agreement is signed.
- 1.2 The preamble to this agreement and the annexure attached there to constitute an integral part thereof.

Article 2: Declarations and Undertakings of the Provider

- 2.1 The provider declares and undertakes that he has all the registrations/licenses/approvals/authorizations required by law in order to provide the services pursuant to this agreement and that he has the skills, knowledge and experience required in order to provide the service as required in this agreement.
- 2.2 The provider undertakes to uphold all of the requirements of the law in so far as those apply to him and in accordance with the provisions of the law and the regulations, which are enacted, from time to time, by the local bodies/by the Central or State government, including a complete system to dispose of Bio-Medical Waste.

- 2.3 The provider declares that he has never committed a criminal offence which prevents him from practicing medicines and that no criminal charge of any kind has ever been filed against him due to medical malpractice and / or no civil claim has ever been filed against him due to damage inflicted during medical treatment. The provider also undertakes to inform the TCC of any complaint of medical malpractice, which may be filed against him during the period of the agreement.

Article 3: Services

- 3.1 The provider undertakes to provide the service in a meticulous, precise, reliable, professional manner and at the highest level of service, to the complete satisfaction of both parties and in accordance with additional instructions to be issued from time to time by and brought to the attention of the provider.
- 3.2 The provider shall treat TCC beneficiaries in a courteous manner and according to good business practices,
- 3.3 The provider will extend priority admission facilities to the beneficiaries, whenever possible. However the right of treatment will always be the prerogative of the provider.
- 3.4 Provider shall ensure that medical treatment/facility with all due care and accepted standards is extended to the beneficiary.
- 3.5 The agreement is subject to the detailed schedule of services is free of cost submitted by the provider, which has to be accepted by TCC.
- 3.6 Provider shall allow TCC official to visit the beneficiary. TCC shall not interfere with the medical treatment of the student. However, the medical team of TCC reserves the right to discuss the treatment plan with treating doctor.
- 3.7 Providers shall also endeavor to comply with future requirement of insurer like standardized billing, ICD-10 coding etc and if mandatory by statutory requirement the provider and TCC agree to review the same. In case provider doesn't have such facility at their end, they agree to get such things outsourced by any outside agency at their own cost. TCC may assist the provider in organizing such outside agency.
- 3.8 Provider agrees to display at their own discretion their status of preferred provider of TCC at their reception / admission desks along with the display and other materials supplied by TCC whenever possible for the ease of its beneficiaries.
- 3.9 The provider will convey to their attached consultant to keep the beneficiaries only for the required number of days of treatment and carry out only the required investigation & treatment for the ailment, which he is admitted. Any other incidental investigation required by patient for his benefit are not payable by insurer / TPA and the consultant will have to inform the patient that he will have to bear the cost of the same. If any unforeseen complications occur same will be included, and permitted as necessary treatment. The treating physician will at all times have the right to treat the patient, as he considers fit and necessary.

Article 4: Employer-Employee Relationship Shall Not Exist

- 4.1 It is agreed that no employee-employer relationship shall exist between the parties and that the provider services are free of cost and for this benefit of the students community



Article 5: Limitations of Liability and Indemnity Insurance

- 5.1 TCC will not interfere in the treatment and medical care provided to its beneficiaries. TCC will not be in any way held responsible for the outcome of treatment or quality of care provided by the provider.
- 5.2 TCC shall not be liable or responsible for any acts, Omission or commission of the Doctors and other medical staff of the Provider.
- 5.3 In the framework of his work with the Institution, the provider will be insured adequately by the professional indemnity insurance.

Provider will ensure that ALL the medical personnel / specialists working, whether full time/part-time, honorary or visiting, in his hospital has their own and adequate professional indemnity Insurance to cover themselves





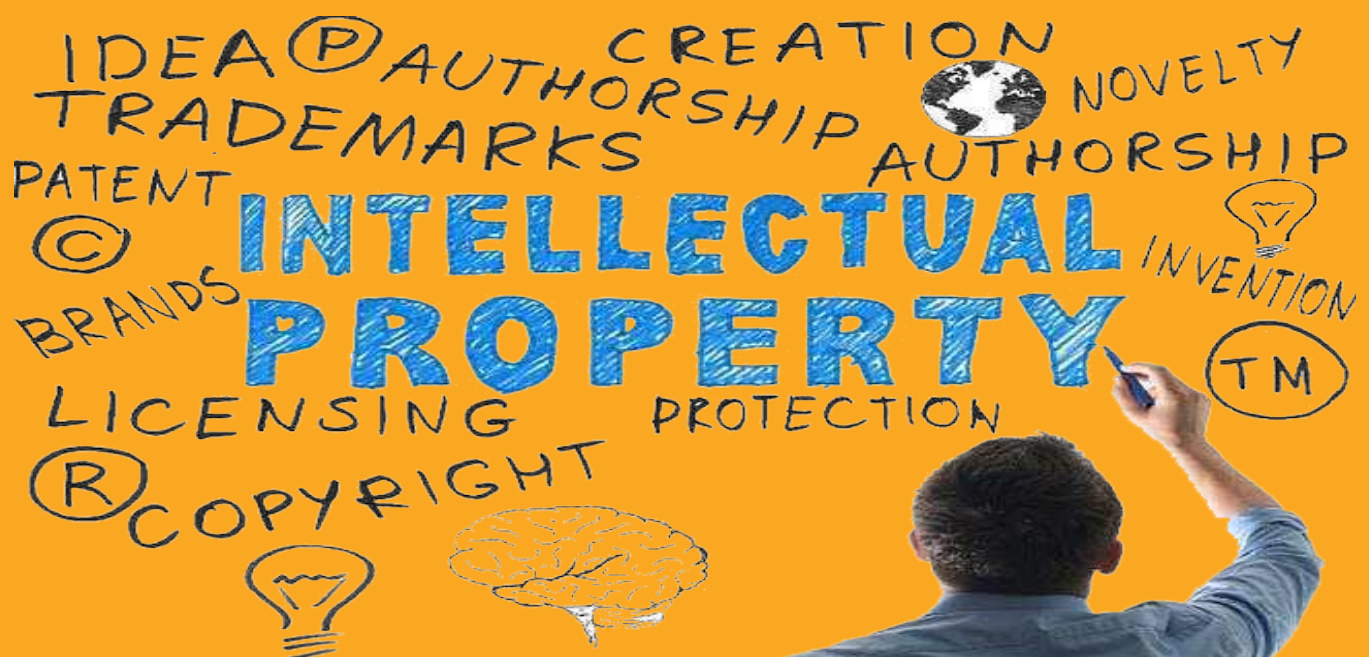
