# MEMORANDUM OF UNDERSTANDING BETWEEN TOLANI COMMERCE COLLEGE-ADIPUR

AND

## GANDHIDHAM CHAMBER OF COMMERCE AND INDUSTRIES GANDHIDHAM

#### A) The Parties:

Tolani Commerce College-Adipur (hereinafter "Tolani Commerce College (TCC)" and Gandhidham Chamber of Commerce and Industries, Gandhidham (GCCI), wish to conclude this memorandum of understanding (hereinafter: "MoU") to facilitate the development and support of collaborations, internship and placement in the member industries and firms for the skill development programmes to be run at Tolani Commerce College-Adipur.

Gandhidham Chamber of Commerce and Industries, Gandhidham is a recognized body of an association of persons from commerce and industry catering service to the benefits of its members of Kachchh district. The chamber is also doing activities in the field of commerce and management. It is well known for fulfilling its social accountability and responsibility in the surroundings of Adipur and Gandhidham in Kachchh district.

Tolani Commerce College-Adipur and Gandhidham Chamber of Commerce and Industry, Gandhidham recognize their strengths in their mutual interest in engaging academic co-operation. Tolani Commerce College and The Gandhidham Chamber of Commerce and Industry, Gandhidham agree to establish collaborative efforts for skill development courses, internship and placement of the students of skill development programs at TCC in accordance with the terms and conditions as set out in this MoU.

All activities arising from this MoU is supported by Tolani Commerce College, Adipur and The Gandhidham Chamber of Commerce and Industry, Gandhidham.

#### B) The Objectives:

- 1. To establish a skill development center at TCC adipur.
- 2. To cater the needs of the students in terms of skill-based program.
- 3. To give students an opportunity for internships and placement.
- 4. By means of collaboration, to strengthen the relationships between the Institute and the Industries
- To foster collaboration providing opportunity to the students of Tolani Commerce College Adipur to facilitate the Advancement of service, on the basis of reciprocity, best efforts, mutual benefit and interactions.



### C) Areas for Collaboration:

Tolani Commerce College and The Gandhidham Chamber of Commerce and industry, Gandhidham, agree to explore the possibility of engaging in the following areas of collaboration:

- The Gandhidham Chamber of Commerce and industries, Gandhidham will donate 25 computers with required infrastructures to establish a skill development center at Tolani Commerce College, Adipur.
- Tolani Commerce College will run different skill-based courses through this center for the benefits of the students
- The Gandhidham Chamber of Commerce and industry will provide an expert ship to the center from its own member industries for the smooth conduction of the courses as and when required.
- The Gandhidham Chamber of Commerce and industry will not be liable for any financial liabilities after the
- This collaboration is meant to strengthen the student-industry and industry-institution social relationship for the betterment of the future generations.
- To make the students direct employable in the corporate market after the successful completion of the course.
- The development and implementation of special activities based on this MoU will be separately negotiated and agreed between Tolani Commerce College and The Gandhidham Chamber of Commerce and Industry which carry out the specific projects. Each party agrees to carry out these activities in accordance with the terms and conditions written in this MoU.
- It is understood that the implementation of any of the types of co-operation stated above shall depend upon the availability of resources and financial support of the parties concerned.
- The course designed and structures shall be updated time to time as and when required with the consent of both the parties.

#### D) Term and Termination.

- This MoU will effect from the date it is signed by representatives of the two institutions. It will remain valid for a period of Ten years (2032), and may be continued thereafter after suitable review and agreement.
- . This MoU may, at any time during its period of validity, be terminated by one of the parties upon prior notice to the other in writing not later than six months before the termination date and Gandhidham Chamber of Commerce and Industries, Gandhidham will ensure that all the programs in progress are allowed to complete successfully.
- This MoU may only be amended of modified, by an agreement signed by the representatives of each party
- The parties may disclose certain confidential information of the other in relation to any future proposal made under this MoU. Each party therefore agrees that the contents of this MoU and the negotiations in relation any future proposal remain strictly confidential and each party hereby undertakes not to disclose the same to any third party, save for its professional advisers without the prior written consent of the other party except where such disclosure is required by law (Including without limitation, under freedom of information legislation)
