During the 2018–2019 academic year, an external expert Dr. Kalpesh Sorathiya is appointed to do the green audit of the college. After skillful observations and evaluations, as per his suggestions, we have made the following changes to the college:

- LED lighting has taken the role of CFLs, and an agreement was made with the local municipality for the appropriate handling and disposal of non-biodegradable waste.
- Faculty, staff, and students are strictly instructed to unplug and turn off electrical appliances when not in use or after usage. Frequent maintenance is performed on the devices to increase their efficiency.
- Regular periodic assessments of water quality are conducted
- Steps are conducted to reinforce the current methods of water management.
- Sanitization procedures are followed for water coolers.

#### **Conserving Energy**

- ❖ Energy-saving gadgets were purchased to preserve energy in the scientific areas.

- ❖ LED bulbs are substituted for CFL and filament lamps via Guj Govt's energy-saving initiative.
- ❖ Staff and students are made aware of the importance of unplugging and turning off electrical items when not in use or after use.

- ❖ As part of the internal and external audit, there is a periodic evaluation of the water quality.

❖ There are numerous competitions held to help pupils become acquainted with the campus's plants and animals.



**1. INTRODUCTION:**

The process of methodically identifying, measuring, documenting, reporting, and analyzing an institution's environmental diversity components is known as a "green audit." Its objective is to examine environmental practices both inside and outside the area in question, since this will affect the overall eco-friendly environment. A college can use a green audit to find out where and how they are consuming the most energy, water, or other resources. From there, the institution can plan how to make improvements and save money. It can raise awareness of health issues and advance ethics, values, and environmental consciousness. It gives faculty and students a deeper comprehension of the effects of green spaces on campus. It is possible to argue that institutional self-enquiry is a natural and necessary development of a high-quality educational institution, if self-enquiry is a natural and necessary byproduct of a high-quality education. Therefore, it is essential that the college assess how it has contributed to a sustainable future.

With environmental sustainability growing in importance for the country, higher education plays a more prominent role in environmental sustainability.

Numerous environmental and ecological crises have been brought on by the fast urbanization and economic growth at the local, regional, and worldwide levels. Given this, it is imperative that institutions implement the Green Campus system, which will promote sustainable development and remove a significant portion of the atmosphere's CO<sub>2</sub> emissions. It is now required that all higher education institutions produce an annual Green Audit Report, as mandated by the National Assessment and Accreditation Council, (NAAC). Furthermore, ensuring that higher education institutions take steps to reduce their carbon footprints in order to help combat global warming is part of their corporate social responsibility.

## **2. OBJECTIVES:**

The Green Audit has gained significant importance in recent times for an institution's self-evaluation, since it indicates the institution's contribution to reducing the current environmental issues. Since the college's founding, efforts have been made to maintain a clean atmosphere. Thus, in accordance with the relevant laws, rules, and standards, the current green audit's goals are to identify, quantify, characterize, and prioritize the framework of environmental sustainability. The primary goals of doing a Green Audit are:

- To chart the college's geographic location
- To record the variety of plants and animals at the college
- To document the weather, air quality, water quality, and noise level of the college.
- To record the meteorological parameters of Adipur, the college's location.
- To record the waste disposal system To calculate the college's energy needs
- To disclose the amount spent on environmental projects over the previous five years

## **3. METHODOLOGY:**

The aim of TCC's green audit is to verify that the campus's actions align with the nation's green policy. The process consists of data collection, campus physical inspection, documentation observation and review, and data analysis.

## **4. ABOUT THE COLLEGE:**

Tolani Commerce College has been recognized as one of the best and most notable institutions for offering excellent commerce education for the past 50 years. The late Kaka Pribhdas Tolani, a visionary and philanthropist, founded the institution in 1973 with the goal of providing all students with a top-notch education. worthy young people without bias of any kind. In honor of its golden jubilee year, the college is hosting the assistance and backing from the employees, alumni, and management. It makes higher education easier by offering a Commerce bachelor's degree. The college was established by the institution's management to instruct youth for academic success in commerce, industry, and business with the aim of offering top-notch instruction in the Kachchh area, which is prone to droughts and earthquakes. It has continuously

## **6. GREEN AUDITING:**

The college has implemented the "Green Campus" concept to promote sustainability and environmental preservation. The three primary pillars are: 100% of graduates exhibiting environmental literacy; zero environmental footprint; and positive influence on occupant health and performance. The aim is Reducing energy, water, and CO2 emissions while fostering a healthy and educational environment for the students.

## **7. OVER VIEW OF THE LAND USE CONCEPT:**

The data acquisition process involved collecting ground control points, geo-referencing and geo-coding satellite imagery (location: 23°04'08"N 70°05'09"E). Ground truth data that was gathered during the field survey was used to facilitate supervised categorization. GIS was used for map scanning, digitization, and editing of all georeferenced maps. GIS software was used for data manipulation, analysis, and linkage between the spatial and attribute data for the production of topology. A land use map displaying the different land uses that have been prepared is the result of the creation of the GIS.

In order to identify land consumption in the built-up land region, an attempt has been undertaken in this work to map land use for TCC using both remote sensing and GIS approaches.

## **8. GEOGRAPHIC LOCATION INCLUDING A SCALE CAMPUS MAP**

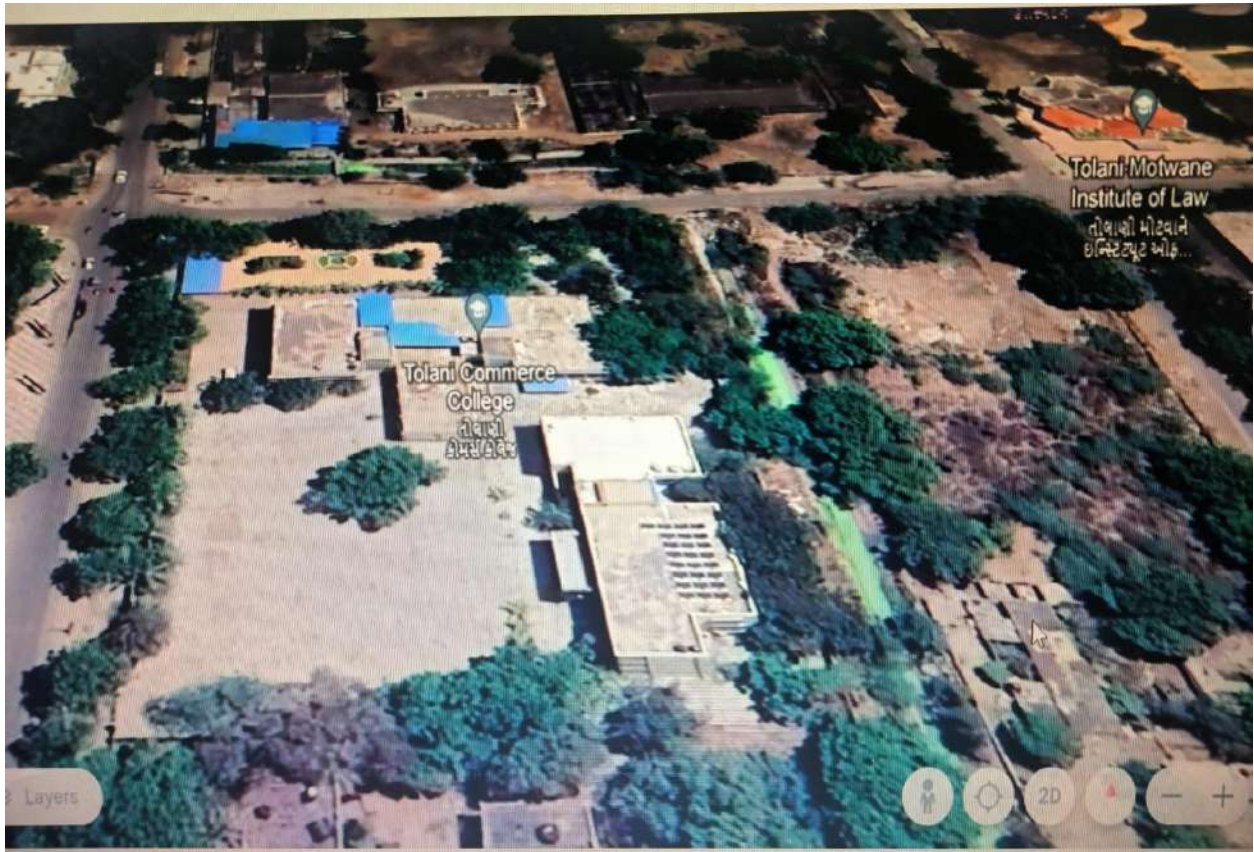
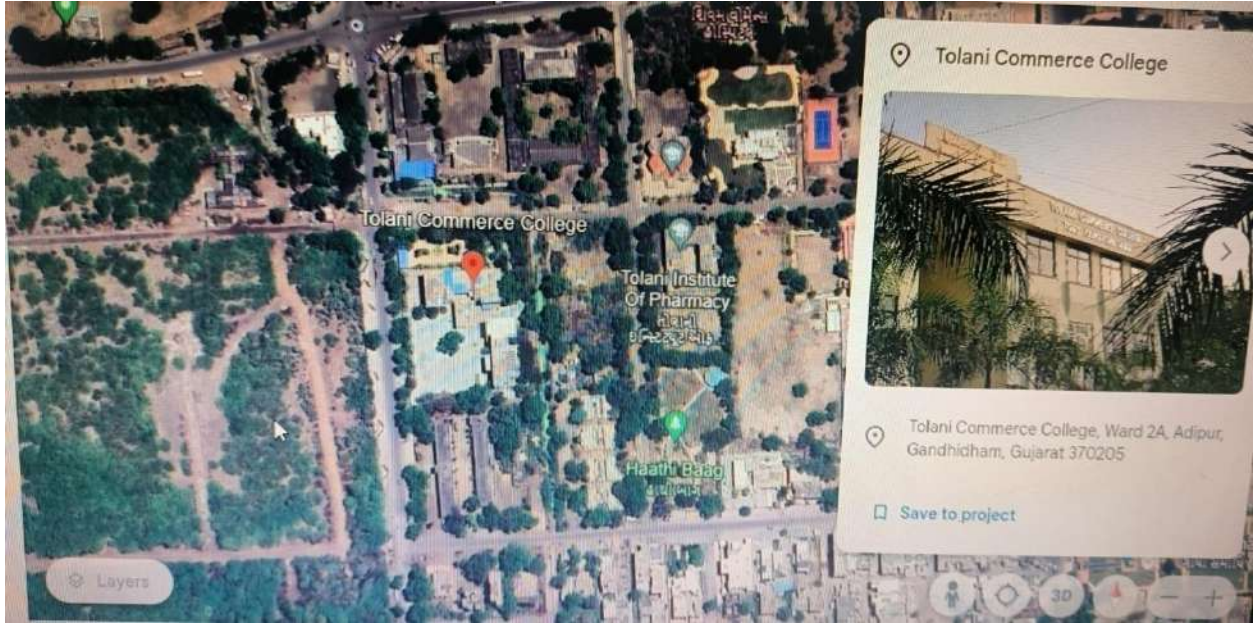

The college covers an area of approximately 1.9 acres. With numerous tree species serving a range of purposes, the location is incredibly diverse. The majority of these tree species were planted over varying lengths of time as part of several plantation programs run by the authorities, and they are now an essential component of the campus. The college's trees have improved the quality of life for everyone around them, including the fraternity and the general public. They do this by supplying oxygen, enhancing air quality, reducing climate change, conserving water, maintaining soil, fostering wildlife, and regulating climate change by reducing the effects of wind, sun, and rain. Summertime temperatures are regulated by the absorption and filtering of solar radiation by leaves. These trees provide food and shelter to a wide variety of birds. Birds and numerous insects love the nectar of flowers and plants. Branches covered in leaves shield a variety of animals from predators, including birds and squirrels. A seemingly infinite diversity of shapes, patterns, textures, and brilliant colors are displayed by different species. As the seasons change throughout the year, even individual trees alter in appearance. Trees have a monument-like character due to their strength, longevity, and royal grandeur. They also serve as a reminder of our institution's illustrious past. These trees frequently evoke strong feelings in us, and occasionally we develop a close bond with the ones we encounter on a daily basis. Large, shaded trees in a thick belt around the college's edge have been found to reduce noise, storms, and dust. As a result, the college has been contributing significantly to preserving the ecosystem around the town of Ludhiana and its environs. The tree species that we are attached to are as follows:

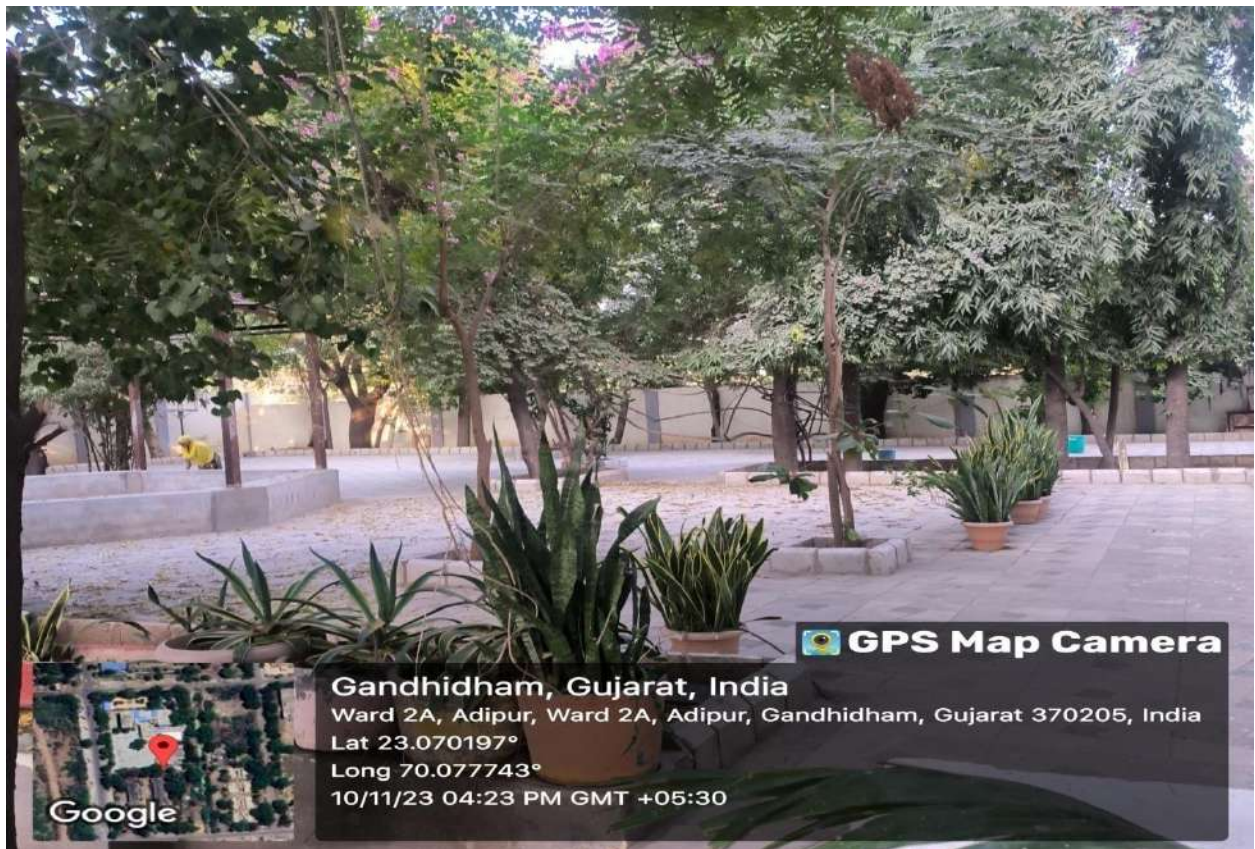

## 12. FAUNAL DIVERSITY:

TCC is situated in west coast of Gujarat known as Kachchh means a shape of tortoise. The industrial city of Kachchh is well-known for its trade and Industries. Its climates are harsh.

During the warmer summer months, average temperatures range from 44 °C to 50 °C. It is possible for the temperature to drop to or below freezing during the winter. Rainfall is primarily seasonal. The majority of the year is dry in the Rann of Kutch, with the June to September monsoon season seeing the most of the region's rainfall. ### **13. AIR QUALITY:**

Numerous factors contribute to the cleanliness, tranquility, and serenity of this area. The ambient air quality data for Kachchh and TCC over the past year indicates that there are relatively few

pollutants in the ambient air; the AQI for SO<sub>2</sub> & NO<sub>X</sub> parameters are within the range of Indian living standards. First off, compared to all other districts in Gujarat, this one has the least population, which is mostly to blame for all issues and obstacles to a comfortable life. Second, compared to other cities, this area has a higher tree planting density.

#### **14. WATER ANALYSIS:**

The significance of water quality testing lies in its ability to detect pollutants and avert water-borne illnesses. Contaminated water can cause serious sickness or even death when consumed or used. For this reason, it's critical to guarantee that drinking water is pure, safe, and devoid of harmful microorganisms.

The intended usage establishes the water quality parameters. Most work in the field of water quality is concerned with treated water for human use or the environment.

##### **Signs of drinking water**

Here is a collection of indications that are frequently assessed according to situational category:

- Alkalinity, water color, and pH value
- Geosmin, 2-Methylisoborneol (MIB), and other flavors and odors
- Dissolved metals and salts (sodium, chloride, potassium, calcium, magnesium, manganese), as well as microorganisms including *Giardia lamella*, *Cryptosporidium*, and fecal coliform bacteria (*Escherichia coli*); see Analyzing bacterial water
- Dissolved organics: colored dissolved organic matter (CDOM), dissolved organic carbon (DOC) □ Dissolved metals and metalloids (lead, mercury, arsenic, etc.) □ Heavy metals

#### **15. NOISE LEVEL IN THE SURROUNDINGS:**

The human ear is continuously assaulted by artificial noises from all directions, and in most populated areas, there are still only a few locations where relative silence is found. Two fundamental characteristics of sound are: **volume and frequency**

The intensity of a person's perceived sound is measured as loudness. Decibels are used to measure it. A whisper is about 20 dB, a jet plane during takeoff is about 150 dB, a rocket engine is about 180 dB, a normal conversation is about 35–60 dB, heavy street traffic is about 60–0 dB, boiler factories are about 120 dB, and just audible sound is about 10 dB. A human can tolerate up to 80 dB of sound without experiencing significant pain. Since sounds beyond 80 dB damage the hearing system, they can be safely classified as pollutants. The safe noise level for a city has been set by the WHO at 45 dB. According to international guidelines, noise levels up to 65 dB are acceptable. Tone is another way to convey loudness. At 1000 Hz, one sane is equivalent to 40 dB of sound pressure. The number of vibrations per second is the definition of frequency. The symbol for it is Hertz (Hz).

### **Describe the location of the college.**

The TCC campus is bordered to the north by the Polytechnic building, and additional canal, to the south by the boys' hostel, to the west by a side open plot and the road, and to the east by Canal, open plot and the residential quarters.

### **16. WASTE DISPOSAL:**

Waste disposal refers to the procedures and actions needed to control waste from the point of origin to the point of disposal. This covers garbage collection, transportation, treatment, and disposal in addition to oversight and control of the waste management procedure.

Every day, the trash from the entire college is divided into dry and moist categories and disposed of differently. Wet waste, on the other hand, refers to organic garbage like vegetable pads and leftover food. Dry waste comprises items like paper, cardboard, glass tin cans, and so forth. Waste separation is crucial since the quantity of waste produced nowadays creates enormous problems. After being composted, the material was assessed for use as fertilizer. When these wastes are disposed of, high-quality organic manure is produced, which can be used as a source of plant nutrients and soil amendments.

Colleges and universities are achieving a higher standard of environmental performance with the support of clever initiatives like the "Think Green Campus Model" in waste management. By reusing or recycling, we lessen the amount of waste that ends up in landfills, save natural resources, and save energy. In addition, we'll lessen our environmental effect by cutting down on the carbon emissions that come with getting new products and getting rid of old ones. TCC uses eco-friendly procedures and takes the required steps, such as recycling waste, cutting energy use, becoming carbon neutral, etc. The other solid trash produced on campus is sent to the communal bin of the Gandhidham municipality for recycling and disposal, while the biological reusable waste is converted into organic manure for the college's plants.


### **17. ELECTRICAL POWER CONSUMPTION AT GNDEC:**

As a matter of policy, the authority continues to swap out old filament, CFL, and tube lights for low-energy LED bulbs and LED tubes, as well as large, high-power fans for energy-efficient fans, with the goal of minimizing the college's electricity usage.

Not only is Environmental Studies an essential subject in our curriculum, but TCC has gone above and above by implementing that philosophy. 8kWp sets of solar panels have been erected by the college located on the new building terrace. The institute's peak daily electricity demand from the grid is partially offset by the energy from this solar array. By installing a 8 kWp grid-connected solar rooftop plant in apex mode, TCC was able to reduce its carbon footprint and move toward a more dependable and environmentally friendly choice by offsetting 34% of its energy use from the state grid.

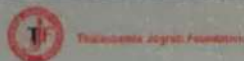
